## IRA Charitable Rollovers

While you may initially appreciate the income from your IRA, as time goes on the higher withdrawal requirements may push you into a higher tax bracket, increasing your taxes

Congress has made the IRA charitable rollover permanent (known as a qualified charitable distribution, or QCD). The QCD allows taxpayers who are required to withdraw money from their IRAs to give directly to their parish. Because the distribution counts toward your required minimum distribution (RMD), but does not count as income to you, making an IRA gift to your parish is a great way to reduce your taxes while supporting your parish.

While you won't receive an income tax deduction for a QCD gift, you also won't pay any income tax on the transferred amount.

The transfer only works for IRAs and not other retirement accounts. You may be able to roll over your 401(k) or other plan into an IRA and take advantage of this strategy. Check with your tax advisor to learn how you can use your RMD for good and lower your taxes.

*Some requirements for making an IRA rollover gift:*

*You must be age 70 ½ or older on the date of distribution.*

*The check must be written directly to your parish from your IRA.*

*You can give annually up to \$100,000 from your IRA.*
